

FANDANGO'S TRIP TO UNIVERSAL ORLANDO SWEEPSTAKES
OFFICIAL RULES ("Official Rules")

NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

BY SUBMITTING AN ENTRY TO THIS SWEEPSTAKES DURING THE SWEEPSTAKES PERIOD, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT. SO READ THEM CAREFULLY BEFORE ENTERING. AMONG OTHER THINGS, THIS CONTRACT INCLUDES INDEMNITIES FROM YOU TO THE RELEASED ENTITIES AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

SWEEPSTAKES PERIOD: The Fandango Trip to Universal Orlando Sweepstakes (the "Sweepstakes") begins at 5:00 AM US Pacific Time ("PT") on May 1, 2025, and ends at 11:59 PM PT on July 4, 2025 (the "Sweepstakes Period"). The computer clock of Fandango Media, LLC (the "Sponsor") is the official time-keeping device in the Sweepstakes. By participating, participants ("Participants") agree to be bound by these Official Rules and the decisions of the Sponsor, which are binding and final on matters relating to this Sweepstakes.

ELIGIBILITY: Sweepstakes is open only to legal residents of the fifty (50) United States and District of Columbia (NOT including residents of Puerto Rico or other U.S. Territories), who are at least eighteen (18) years of age or the age of majority in their state of primary residence (whichever is older) at time of Sweepstakes Entry. Employees, officers and representatives of the Sponsor, Southern Made Services, LLC (the "Administrator"), Universal City Development Partners, Ltd. d/b/a Universal Orlando Resort ("Universal Orlando"), and Universal Pictures Marketing, a division of Universal Film Exchanges LLC ("Universal Pictures"), and each of their respective parents, affiliates, subsidiaries and web-design, advertising, marketing, fulfillment, judging and promotion agencies, or other agency involved in the administration, development, fulfillment and execution of this Sweepstakes, and their immediate family members, as defined below, of each, and household members, as defined below, whether or not related, are not eligible to participate in the Sweepstakes. www.fandango.com (“Fandango Website”) or the Fandango app (“Fandango App”, together with the Fandango Website, the “Platforms”) at Fandango partner theaters in the US during the Sweepstakes Period. You will receive one (1) Sweepstakes Entry, once your ticket has been purchased. **2) Alternate Means of Entry:** To receive one (1) Sweepstakes Entry without making a purchase (“AMOE Entry”, together with Purchase Entries, “Sweepstakes Entries”), visit fandangostriptouniversalorlandosweeps.entertowinprizes.com and enter your full name, complete address (no P.O. boxes permitted), phone number (including area code), and email address by July 4, 2025.

Sweepstakes Entries generated by script, macro or other automated means, and Sweepstakes Entries by any means which subvert the entry process, are void. By submitting a Sweepstakes Entry, you agree to these Official Rules and are willing provide your information to the Sponsor and the Administrator. No photocopied or mechanically reproduced Sweepstakes Entries accepted. Sweepstakes Entries become the property of the Sponsor and will not be returned.

There is a limit of one (1) Sweepstakes Entry per person, regardless of entry method, using only one (1) email address. Participants are not required to opt-in and opting in will not improve your odds of winning.

SWEEPSTAKES PRIZE DRAWING & WINNER NOTIFICATION: The potential Winner will be selected in a random drawing held on or about July 7, 2025. Winner will be contacted via email.

The potential Winner will be required to acknowledge receipt of Winner notification within two (2) days and execute and return an affidavit of eligibility, a taxable income form, a liability release and, where lawful, a publicity release within three (3) days of date of issuance of email to such potential Winner. If such documents are not returned within the specified time period, Prize notification is returned as undeliverable, the Sponsor or its agent is unable to contact a potential Winner or a potential Winner is not in compliance with these Official Rules, Prize will be forfeited and, at the Sponsor's discretion, an alternate Winner may be selected. The Sponsor reserves the right not to award a Prize in the event the Sponsor is unable to identify and confirm a Winner after attempting to contact an alternate potential Winner.

Odds of winning will depend on the number of Sweepstakes Entries received during the Sweepstakes Period.

SWEEPSTAKES PRIZE (1): PRIZE: The prize winner ("Winner") will receive a trip for Winner and up to three (3) guests ("Guests") to Universal Orlando Resort in Orlando, Florida ("Prize"). Prize will include round trip economy class air transportation from a major commercial airport near Winner's home (as determined by Universal Orlando in their sole discretion) to Orlando, Florida; four (4) nights' standard hotel accommodation (one room, quadruple occupancy, room and tax only) at Universal Terra Luna Resort or at another Universal Orlando Resort hotel (as determined by Universal Orlando in their sole discretion); non-exclusive ground transportation to and from airport and hotel in Orlando, Florida; Universal Orlando 3-Park 3-Day Park-to-Park PLUS 1-Day Universal Epic Universe Tickets for admission to Universal Studios Florida and Universal Islands of Adventure theme parks, Universal Volcano Bay water theme park, plus one (1) day admission to Universal Epic Universe, for Winner and Guests. For a Winner who is a Florida resident, air transportation may be substituted with another method of transportation by Universal Orlando in its sole discretion. **The Approximate Retail Value ("ARV") of the Universal Orlando Resort Prize is Four Thousand Nine Hundred Eighty-Seven and 88/100 Dollars (\$4,987.88).**

PRIZE CONDITIONS: Trips must occur from September 1, 2025 – September 1, 2026 or Prize will be forfeited. Travel dates and arrangements are subject to air travel, holiday, blackout dates, and other Prize and travel restrictions. Travel dates are subject to Universal Orlando and Sponsor approval. Reservations are subject to availability. Trip must be booked at least sixty (60) days prior to intended departure date. If terminated, at its discretion, the Sponsor reserves the right to select the potential Prize Winner from all eligible, non-suspect Prize claims received prior to action taken or as otherwise deemed fair and appropriate by the Sponsor. In no event will the Released Parties be liable for more than the stated number of prizes in these Official Rules. Participants, by participating, agree that the Sponsor, the Administrator, Universal Orlando, Universal Pictures, and each of their respective parents, affiliates, subsidiaries and advertising and Sweepstakes agencies and promotional partners and all of their respective officers, directors, employees, shareholders, representatives and agents (collectively, "Released Parties") will have no liability whatsoever for, and shall be held harmless by Participants against, any liability, for any injuries, losses or damages of any kind, including death, to persons, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of a Prize (including any travel or activity related thereto) or participation in this Sweepstakes. California. The Arbitration shall be administered by JAMS in accordance with the Streamlined Arbitration Rules and Procedure of JAMS (available at <https://www.jamsadr.com/rules-streamlined-arbitration/>) or subsequent versions thereof, including the optional appeal procedure.

CHOICE OF LAW AND JURISDICTION: All federal, state and local laws and regulations apply. Void where prohibited by law. Excluding Universal Orlando Prize Claims (defined below), all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any Participant and the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the state of California without giving effect to any choice of law or conflict of laws rules (whether of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than California. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these Official Rules shall be brought only in the courts of the State of California. You hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non-conveniens or lack of personal jurisdiction they may have.
